

**“SMALL WONDERS”
Bastrop County Local Artists
ARTIST AGREEMENT**

This agreement is made by and between Found Fine Art, LLC. (“Gallery”) and _____ (“Artist”) effective as of the _____ day of _____, 20____ (the “Agreement”).

1. REPRESENTATION – Selected Artworks will be exhibited November 6 - December 19, 2026. The Gallery will provide Artwork frame, space, installation, lighting, opening reception, promotion, and sales handling, including the collection of Texas Sales Tax and shipping, as needed. The Gallery will also provide insurance while Artwork is on premises (up to artwork value declared).
2. CONSIGNMENT- Artist agrees to deliver all selected Artworks to Gallery by **October 15, 2026**. Failure to do so may result in disqualification and removal from the showing. Artist is solely responsible for the cost of delivering the artwork to Gallery. All risk of loss or damage to the artwork while the artwork is in transit remains with Artist. Gallery and client will coordinate transportation costs of artwork to client. A Consignment Addendum (attached) shall be completed for each piece of Artwork consigned and is incorporated into this Agreement.
3. THE WORK- Gallery retains the right to select what work will be displayed and in what manner.

Artwork must fit into one of the gallery-provided 8x8, black frames. The Artist shall pick up their provided frame from the gallery upon notification of selection. Artist shall be responsible for installing their piece into the frame. Use of provided glass is optional. Artist may modify the look of their frame, but they MAY NOT modify the size or hanging mechanism of the frame.
4. EXHIBITION/RECEPTION –Gallery will host an opening reception for the show on **November 6, 2026**, beginning at 5pm. All Artists and their guests are encouraged to attend.

Gallery may use Artist-provided or Gallery-provided photography, direct marketing, and/or internet presence, to complete the sale of the Artwork.

Unsold artwork will be available for **pick up December 22 & 23**, 10am-6pm or after January 5, 2027.
5. PUBLICITY – For the duration of the exhibition, Artist may include Gallery’s name and contact information, including physical address, phone number, website, or social media links in any marketing or promo on of the Artwork. Gallery is authorized to utilize any available logos and marketing/promotional materials (both print and digital) for Artist to advance the sale of the Artwork.
6. PAYMENT/COMMISSION – Artist will determine the selling price of Artist’s artwork and Artist must provide this information to Gallery. Upon the sale of Artwork, Gallery will receive 50% of the selling price. Compensation for artworks that were sold during the show will be issued within 10 days of the closing of the show.
7. AWARDS – All Artwork selected for the exhibition will be eligible to win one of 3 cash awards.

The jury will award the following at the Artist Reception on November 6:

1st Place \$300 / 2nd Place \$200 / 3rd Place \$100.

8. TERMINATION – Either party may terminate this Agreement at any time, for any reason. Termination shall be effective when either party serves written notice thereof on the other party, including via letter, text or email. Artist shall remove artwork from the Gallery within 3 days of notice, and at the Artist's expense.
9. REPRESENTATIONS/INDEMNIFICATION—Artist represents and warrants that all consigned artwork is free and clear of all liens, security interests or other encumbrances and does not infringe on or misappropriate any patent, copyright, trademark, trade dress or other intellectual property right of a third party. Artist agrees to defend and indemnify Gallery from and against any claims that any consigned artwork infringes upon an intellectual property right of a third party.
